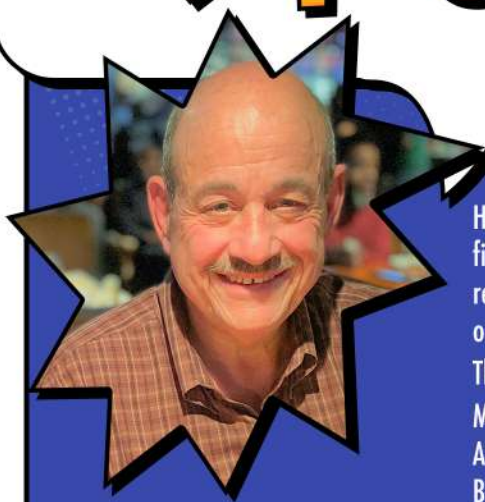

LETTER FROM THE FOUNDATION PRESIDENT

Heroes can be anyone. Frontline workers during this past year are the heroes of our time putting others first and putting their own lives on the line for all of us. Workers who kept the shelves stocked, worked in restaurants and so many others who went out every day to work are included in this group. We all have our heroes. Our family, a friend, or a boss who taught us so much.

The Brothers of Alpha Chi Rho have some heroes in the Alpha Chi Rho Educational Foundation as well.

Maron E. Turner, Gordon Patterson, and Bayard W. Allmon were the men who called the first meeting of AXPEF. John R. Hunter, Wilbur M. Walden, Carlton J.H. Hayes, William H.D. Cox, P. Ormond Milton, Amos B. Horlacher, Walter W. Patchell, F. Prescott Hammond, Horace R. Bassford, Frank E. Masland, Jr., G. Alfred

Palmer, and Theodore Seidel were our first twelve Trustees. These Brothers understood the value of education and envisioned a way to provide financial assistance to the Alpha Chi Rho men who needed it most. In 1950, Alpha Chi Rho being one of the youngest national fraternities, became one of the first to establish its own public charitable organization.

F. Prescott Hammond was elected as the first Chairman of the Board. A member of the Phi Omega Chapter and graduate of Columbia University in 1922, he received his law degree from Columbia Law School and was a member of a prestigious New York law firm. Brother Hammond passed away suddenly in 1956 and, much to the surprise of his fellow Board members, he left his entire residuary estate to the Foundation. His bequest enabled the Alpha Chi Rho Educational Foundation to become one of the largest fraternity foundations at that time.

A true visionary, Hammond saw past the immediate needs of the Fraternity and planned for what his successors would need to continue to expand and support all educational pursuits of our men. This superhero, who gave over \$350,000 to the Foundation in 1956, single-handedly created an endowment that not only funded a scholarship in his name, but has funded 60 years of Leadership Institutes, Convention educational programs, grants and loans. It is the corpus of the Foundation that has allowed our organization to continue to build.

There were others who added to our endowment over the year: R. B. Stewart provided the seed money to purchase the very first house for the National headquarters in 1983. Don Jones, past National President and Foundation Chairman bequeathed \$100,000 on his passing which saved the educational initiatives in the 2000s. We remember even more heroes in the names of thirteen scholarships, including recent funds established in memory of Colin Rochester and Wes Dangler. There are so many more heroes to add to the list, all of whom made the Foundation strong. We are lucky to have had these men as our Brothers.

Who will be our superheroes now? Will you be part of the next league of extraordinary men to sustain our educational programs and financial assistance plans? Will you list AXPEF in your estate plans or as a beneficiary for your retirement or life insurance plan? Or will you join our newest heroes like Jeff & Patti Sands (Phi Psi, 1977) who pledged \$25,000 to create the Weston L. Dangler Scholarship? Or Bob Weiss (Phi Kappa, 1955) who gave \$100,000 in appreciated stock to the Foundation?

Some of you have made plans or included AXPEF in your living will and we may not know about it yet, but we thank you. There are close to 500 Brothers and friends who gave this past year to the Foundation, half of whom have been giving consecutively for years. You have allowed the Foundation to fulfill its mission and be the heroes our predecessors envisioned we would be.

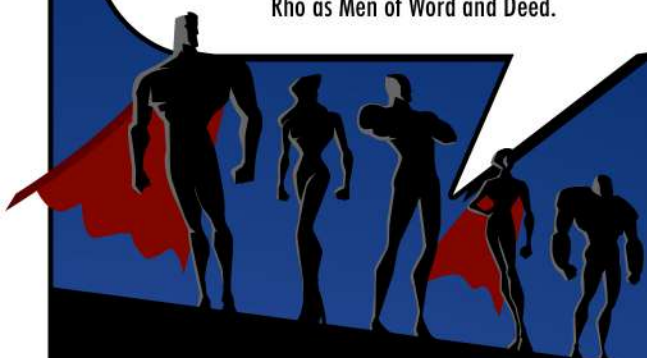

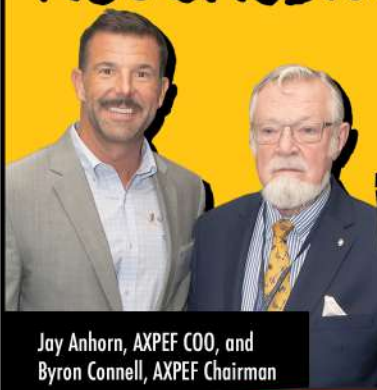

REVEALING OUR TRUE IDENTITY

The 2020 Survey of Alumni and Supporters, developed under the auspices of the Foundation for Fraternal Excellence (FFE), is the largest single piece of research ever conducted with fraternal alumni. More than 128,000 fraternity and sorority alumni and supporters from 37 different Greek organizations participated in a national study that gathered information on the opinions, attitudes, and preferences of alumni and donors between March and August 2020. The 100-question survey touched on a wide-variety of topics related to the fraternal experience and engagement after leaving higher education. Complementary to the survey is an analysis of fraternal foundation support, which allowed Cygnus Applied Research to measure and evaluate changes in giving trends over the last five years from database records. These giving benchmarks track the philanthropic decisions of more than 4.6 million alumni and almost 250,000 donors over the last five years.

To our surprise, the overall response rates from AXPEF active donors (31%) and Lifetime Giving Society members (47.5%) were significantly higher than our peers (26.4% and 34%, respectively).

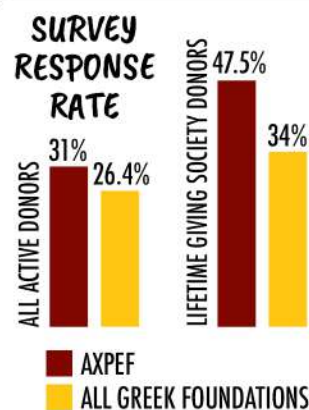

FASTER THAN A SPEEDY INTERNET CONNECTION: THE SUMMER INSTITUTE GOES VIRTUAL

The purpose of the InDeed Institute is to educate rising leaders in the Fraternity on how the Landmarks and principles of Character, Honor, and Integrity affect their Chapters and daily lives. The COVID-19 pandemic caused the 4-day, 3 night experiential learning program to shift to an original curriculum of virtual sessions in the month of July on topics that were timely and relevant to our men.

With 92 men registered for the two main educational programs, 94% of the Chapters and Colonies had representation.

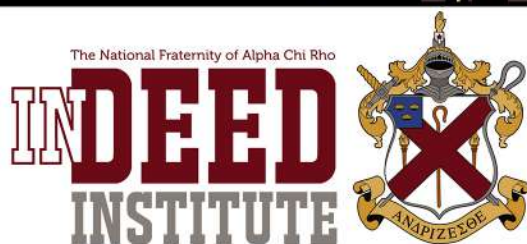
This program reinforced the environment of communal support a fraternity provides and how a Brotherhood can diminish the impact psychological trauma has had or can have on one of its members. Physical and emotional indicators of trauma were explained to assist our collegiate Brothers in identifying those who may need help but are unaware of resources available to them.

Recruitment Digital Classroom

Our friends at Phired Up! Productions developed an online course for all Chapter members that focused on how to make meaningful connections in a virtual world. The interactive program was packed full of videos, lessons, and resources that helped our men learn the fundamentals or marketing, recruiting with technology, the art of "Social Excellence" and making authentic connections.

THE FRATERNITY AND FOUNDATION DRESS UP A SIGNATURE EVENT

Over ninety Brothers and guests gathered for the Winter Conclave in late January 2020. Unbeknownst to anyone, this would be the last in-person program before the pandemic. Over the course of three days, Alpha Chi Rho men served the local community, learned best practices for their Chapter operations, and visited the national office for the first time.

While many of our members were traveling down to New Jersey for the Conclave on Saturday, twelve Brothers and staff gathered to volunteer with the St. Bernard's Project (SBP) in Toms River, NJ. Brothers spent 8 hours helping a local woman (April), remove, clean, and store items from her home that was destroyed by super-storm Sandy in 2012. April told SBP, "having Alpha Chi Rho as the first volunteers at [my] home really made the idea of moving back home a reality. The Alpha Chi Rho Brothers were enjoyable, diligent, considerate, kind and most of all compassionate throughout the entire experience."

On Saturday, the Conclave officially began at Monmouth University. Throughout the course of the day, Chapter delegates learned our new online financial management platform, recruitment and event management skills, health and safety standards from our keynote speaker, Stefano Fasulo, and our staff. The Conclave ended with a reaffirming of the Landmarks and a goal setting activity to accurately gauge what the Chapters learned at Conclave. Fourteen members stayed for a tour of R.B. Stewart National Headquarters and participated in initiating members from the Phi Beta Chi Chapter at Radford University.

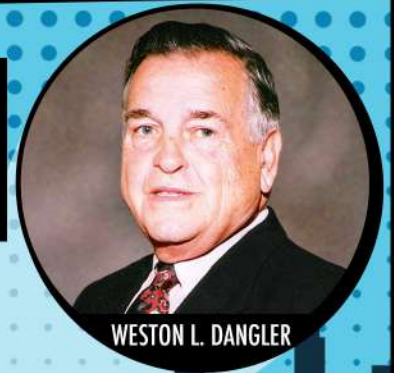

Magic is unexplainable, intangible and (almost) unbelievable. But you know it when you feel it. Brotherhood has that same effect. Alex's story is a powerful example of that magic.

In the fall of 2012, Alex Bartlett began his first semester at Lock Haven University as a commuting student from Mill Hall, PA, just minutes from campus. By second semester, he moved on campus into North Hall, and met two men, Landon Allen and Brent Juster, who would become his best friends and Alpha Chi Rho Brothers.

Alex lost his battle with testicular cancer at the young age of 26 in June 2020 surrounded by his family, fraternity Brothers, and close friends. Throughout his short but incredibly meaningful life, Alex touched more lives than can truly be counted. His final wish was to selflessly donate his body to science. Even in eternal rest, Alex will continue to aid medical researchers, in the hopes of finding a cure for cancer. Later that fall, the graduate Brothers of the Phi Mu Chi Chapter, along with Alex's family and friends, decided to honor Alex by securing his legacy through AXPEF with donations in support of scholarships and grants in his name.

Landon Allen, Phi Mu Chi (Lock Haven 2017), benefactor of the fund, stated, "[It] was created to continue Alex's passions and empower those in education, community involvement, and wellness. Alex liked giving back to his community and helping fellow students. He had a passion for continuing to better himself through education and wellness. This opportunity allows us to continue his dream and legacy."

In October 2020, the Trustees announced the establishment of the Alexander C. Bartlett "Well" Endowment which, once fully funded, will provide an annual scholarship to a senior from Alex's high school alma mater and a scholarship to a member of Alpha Chi Rho on any campus. The fund also provides a \$500 wellness grant to be given to one Chapter of Alpha Chi Rho to educate their campus on identifying the early signs of testicular cancer and the importance of monthly self-exams.

"Alex was able to impact and help out so many people during his undergraduate years in the Fraternity," said Brent Juster, Phi Mu Chi (Lock Haven 2017). "We hope to continue his name and help others grow and develop with the endowment."

Gary DelPiano, President of the Alpha Chi Rho Educational Foundation, remarked: "This is a unique fund because it not only provides annual scholarships, it challenges and inspires young college men in Alpha Chi Rho to educate their peers on men's health issues through Alex's story."

The Fund continues to accept donations with the hope of impacting more college and college bound students. The magic of Brotherhood is one of the greatest superpowers that never fails.

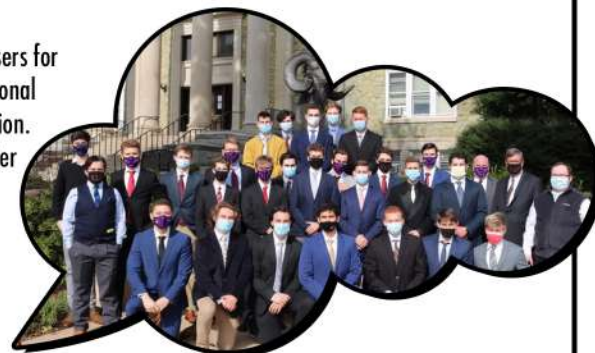
PHI NU CHI RETURNS TO WEST CHESTER UNIVERSITY

In 2017, graduates of the Phi Nu Chi Chapter and National staff petitioned to bring Alpha Chi Rho back to West Chester. In the spring 2019 semester, the Colony formed. Five men across different disciplines of academia came together to restart the Chapter. What brought them closer together was their understanding of the responsibility they held with building this organization from the ground up. Throughout the Colonization, the National Fraternity provided a full-time staff member to assist the men in reaching the goal of Re-Institution.

After much work from the students and staff, the Colony was approved for Re-Institution on March 14, 2020. However, due to the COVID-19 pandemic, the Colony was Re-Instituted on October 10, 2020. The Initiation and Re-Institution ceremony were conducted in accordance with all West Chester University COVID-19 policies, state of Pennsylvania COVID-19 ordinances, CDC guidelines, and Fraternity COVID-19 regulations.

Throughout the spring 2020 semester, the Colony hosted virtual fundraisers for Habitat for Humanity, the Ronald McDonald House, Color of Change, the National Breast Cancer Foundation, and the American Foundation for Suicide Prevention. In November 2020, the Chapter hosted their own event to benefit the Chester County Food Bank. The Colony canvassed the local neighborhoods asking for food donations and then the week before Thanksgiving collected all donations on the residents' porches. From their neighbors' generosity and their own donations, the Chapter donated 321 pounds of food.

The Graduate Chapter has continued to be involved virtually with the Chapter. Monthly, the Graduate officers meet with their counterparts and discuss the Chapter's operations and how they can assist. The Brothers understand the connection of alumni support and how that will give the Chapter a long life. To quote the Re-Founding president Joshua Adams, "[The Chapter] will set the example of what it means to be a true leader. We will provide the necessary assets to aid in the development of all our men. The process of working together as a team grows a true Brotherhood."



THE FIRST COLONY EVER IN SOUTH CAROLINA - COASTAL CAROLINA UNIVERSITY

The decision to expand at Coastal Carolina University was quite simple, to grow the Fraternity's southern presence. After presenting to the Greek community, the Fraternity began their expansion efforts in spring 2020.

Leadership Consultant Anthony Mussari (Alpha Phi Theta, '20) recruited the first group of Founding Fathers to establish the Colony. After the University went remote due to the COVID-19 pandemic, Anthony continued educating and recruiting men virtually. Nicholas Ramos (Theta Chi Phi, '20), the current Leadership Consultant, began working with the Colony in the fall 2020 semester. Anthony and Nicholas laid the foundation for the Colony and provided them the tools they needed to become a Chapter. They attended countless meetings, trained all officers and chairmen, conducted new member education both in-person and virtually, held interviews for potential new members, supported recruitment efforts (with time and money), and helped construct and pass the Colony's bylaws.

The Colony currently has twenty-four energetic members that are ready for any challenges they may face. The current president of the Colony, Alex Moran, said, "Alpha Chi Rho at Coastal Carolina University is the main reason why I have developed into the gentleman I am today." Another member, Tyler Freund, says, "I joined Alpha Chi Rho as a junior with little to no intention of joining a fraternity. I am happy to say that I was gravely mistaken...the dedication of my fellow members and our advisors really pushed us into a place I never would have thought we would be, given the circumstances." With an average cumulative GPA of a 2.99, the members implemented a plan to improve their academic excellence while preparing the petition for Institution. The Colony continues to persevere during the pandemic by continuing their philanthropic efforts with Habitat for Humanity (which they donated \$200 to last semester). They also continue to collaborate with other organizations on campus and with their local community.

Q Why do you think this day of giving is important?

A It's a way for AXPEF to engage and 'charge up' the membership to give back, especially those Brothers who received a scholarship or loan from the Foundation.

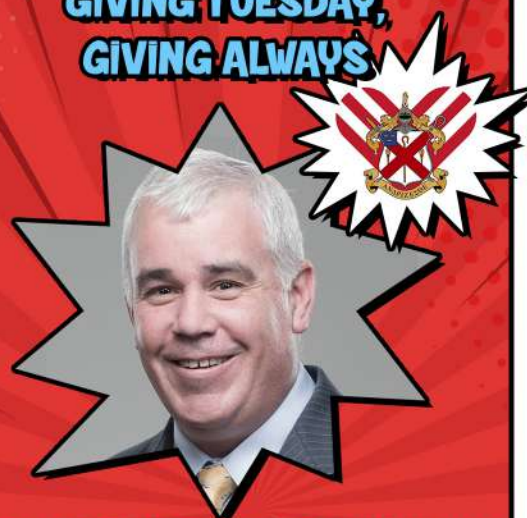
Q How do you support this campaign?

ABLE TO LEAP TALL HABITATS IN A SINGLE BOUND!

At the 105th National Convention, the Fraternity dedicated its sole philanthropic focus to Habitat for Humanity. During that Convention, delegates participated in a Day of Service at the Burlington County and Camden County Habitat Re-Stores. The Brothers helped organize and restock inventory.

Since the Convention, many Chapters held events or fundraisers for the international organization or local branches. Throughout the COVID-19 pandemic, our Chapters and Colonies have continued their volunteering and philanthropic efforts for Habitat for Humanity. For example, the Phi Gamma Chi Chapter at The College of New Jersey raised \$300 through their annual "Camp Crow!" event. The Alpha Phi Zeta Chapter at Seton Hall University accepted monetary donations totaling \$450. The Colony at Coastal Carolina University placed first in a social media contest and was awarded a \$200 donation.

FROM OUR INTERFRATERNAL FRIENDS

The Alpha Chi Rho Educational Foundation committed to sponsoring resident delegates to attend the Northeast Greek Leadership Association's (NGLA) annual Leadership Conference. "NGLA is a volunteer-driven nonprofit organization of dedicated individuals working to develop and educate students and professionals in the Northeast. [They] provide educational experiences and programming with the goal of helping the fraternal community align actions with values. [They] strive to promote learning, community building, values-based leadership, and overall well-being of students and professionals." (<https://www.ngla.org/about-ngla>)

Since 2017, the Educational Foundation has sponsored thirty-three delegates from twenty Chapters. In 2019, the Foundation assessed the impact of sending delegates to NGLA and found the Chapters that attended did not have a holistic benefit to attending compared to their host Institutions sponsoring delegates. However, the Foundation reaffirmed their commitment to sponsor delegates and sent delegates to the 2020 and 2021 Conferences. The 2021 Virtual Conference allowed the Foundation to sponsor more delegates.

After every Conference, the delegates are asked to provide a thank you letter to the Foundation. One delegate said, "I really enjoyed the healthy masculinity sessions I attended. Our Chapter has many members who struggle with some form of mental health. Often, those struggles are masked by 'I'm okay!' or by always being happy. I don't think we, as a Chapter, have the emotional intelligence to pick up on such cues. This is part of the reason I do two week check-ins, scheduled a mental health workshop for a Chapter meeting and constantly, especially now, preach looking out for one another and reaching out whenever needed. Most importantly, I state to not judge each other or anyone else because no one knows what anyone is thinking." Another delegate said, "During these three days I have learned so much from our keynote speakers and other Brothers from different Chapters around the country. The takeaways from my experience include how to improve our Chapter's recruitment, event ideas, and how to get Brothers more involved in our Chapter and community. This was a conference I will not forget, and I thank you for allowing me to attend such an influential event!"

He and his wife, Leah, a proud member of Gamma Phi Beta sorority, reside in Chapel Hill, North Carolina and took my recent call to talk about his commitment to the Foundation. We had such an engaging conversation that I could barely write down notes for this article.

Q Why is giving back to your Chapter so important to you?

I had a marvelous time in Champaign. The Fraternity turns a boy into a man. I got a lot out of being an Alpha Chi Rho Brother and appreciate hearing updates from the Phi Kappa Chapter today.

Really, the same as my previous answer. Learn to grow together on your path to become a man. I hope the next generation of Alpha Chi Rho men learn to, well, "Be Men". Q What would you say to another Brother to convince him to give to the Foundation?

Every superhero has an origin story, and Nancy Jones' involvement is no different. For years Nancy was in the orbit of the Foundation and the Fraternity through her husband, Don Jones, a 1968 Pharmacy graduate of Purdue University and member of the

Alpha Phi Chapter of Alpha Chi Rho. Over the years, Don held various leadership positions including National President and Foundation Chairman and was awarded

Graduate Man of the Year. Nancy was a silent partner in Don's full support of the Fraternity and Foundation.

When Don passed in 2004, Nancy decided to create a legacy in his memory through the Foundation's scholarship program, creating two scholarships for graduate and undergraduate Brothers. *"Don's ability to attend college was because of receiving financial assistance himself. This was a way for us to pay it forward as Don would have done,"* Nancy recalls.

Nancy didn't end her involvement with the Foundation there. Like Don's practice of mentoring and developing those in his sphere, Nancy's service and financial support continued. Most recently, she chaired the 2020 committee charged with updating the Foundation's Mission Statement.

Nancy's forward-thinking intent was evident: *"The Foundation Mission Statement had not changed in thirty years, but the Foundation's mission has! In fact, it changed as the needs of the young men have changed. The Foundation does not simply provide financial support; it supports academic programs and services that encourage growth, maturity, and service to the larger communities where we live and work. It is value-driven and aligned with the needs of the Brothers striving to 'Be Men' while adhering to the Landmarks."*

These significant contributions have not exhausted Nancy's superpowers. She continues to serve and contribute to the Foundation and will chair the Strategic Planning Committee this year. Why does Nancy give, and why should others consider giving? *"Contributing to the Foundation expands our ability to create new educational opportunities and support systems for the future. It's also a way for donors to recognize someone's legacy or to simply make a difference by their actions."*



THESE MEN MET THEIR MATCH!

Do you know if your company has a matching gift program for charitable organizations? AXPEF is an IRS recognized 501c3 charity, so ask your HR/Employee Benefits department to add "Alpha Chi Rho Educational Foundation, Inc." as a recipient and file your 2020 donations.

Two of our Trustees, Andy Borner, Phi Beta (Dickinson 1992) and P. Martin Sharpless, Phi Lambda (Penn State 1983) have been utilizing their employer match programs for many years and actively seek them out when they have changed jobs.

I joined Intuitive Surgical in May this year and have found a home at a highly philanthropic organization. They offer a generous match up to \$4,000 each year for approved non-profit organizations. I just show them receipts for my annual giving to generate the match funds I may be able to withhold direct to the Intuitive Surgical Foundation for giving from non-taxable funds as well, but I haven't explored that option yet. I recommend checking with your employer before the year is out if they offer matching funds!

NEW "HEALTH & SAFETY" GRANTS SAVE THE DAY!

In response to concerns by students and parents about campuses reopening in Fall 2020, the Programs & Services Committee created a new "Health & Safety" grant focusing on the health and safety of Brothers interacting within their larger campus communities. The grant was intended to assist resident Chapters with up to \$250 of educational expenses relative to members' health, safety, and well-being on campus and in Chapter housing, as they transition to campus life, remote or not. Monies are utilized to pay for PPE supplies like hand sanitizer, face masks, and educational signs, materials, or speakers.

In the early stages of COVID, AXPEF recognized the financial hardship on many of its young graduates in student loan repayment and initiated a deferment for all active student loans through the end of 2020.



CHIVALRY IS NOT DEAD!

THE GARNET KNIGHT CHALLENGE

The Garnet Knight Challenge was developed for Brothers of Alpha Chi Rho to stay physically active and virtually connected while supporting communities in need during the COVID-19 pandemic. Through the fundraising efforts of members of Alpha Chi Rho on the way to achieving personal athletic goals, the Educational Foundation is mobilizing its members in a healthy and positive way to support communities and families in need. This Challenge is intended to inspire our men to set high yet reasonable goals and use their social and philanthropic learned behaviors to positively impact themselves and the greater good.

All members of Alpha Chi Rho (resident and graduate Brothers, Postulants and Colony members) that are in good standing are eligible to become a Garnet Knight. Each candidate must identify an athletic endeavor of his choice (any type of physical activity or fitness goal) and achieve it, and commit to raise at least \$1,000 through his personalized donation page through the AXPEF website. This is a joint fundraiser to benefit the Foundation and the candidate's choice of one of our 2020-2021 charity partners, Habitat for Humanity and Feeding America. While there is no deadline for the fundraising or athletic endeavor, Brothers will be "knighted" every summer following the academic year.

While the Foundation will award the first set of medals and "knight" the first order in June 2021, it was inspiring to see National President, David Jost, Eta Phi (Gettysburg 1975), jump into this challenge with both feet (and wings!). Brother Jost surpassed his fitness goals by completing 170,594 strides on the elliptical machine and lifted a total of 154,835 pounds in 30 days. He also raised \$1,075 from his family, friends, and Brothers.

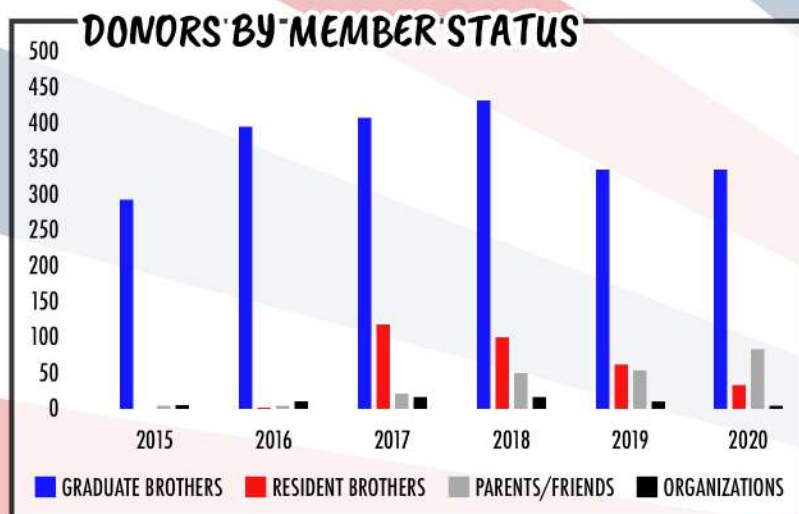

If you are over the age of 70 1/2, you can send your IRA distributions directly to AXPEF. Distributions from your IRAs in the form of QCDs are not taxable on your Federal Income Tax return. The distribution is reported on your Form 1040 with a "QCD" annotation and it is not taxable income. Further, if you live in a state where Federal AGI is the starting point for your state income tax return, you will also benefit from no state income tax on the QCD amount.



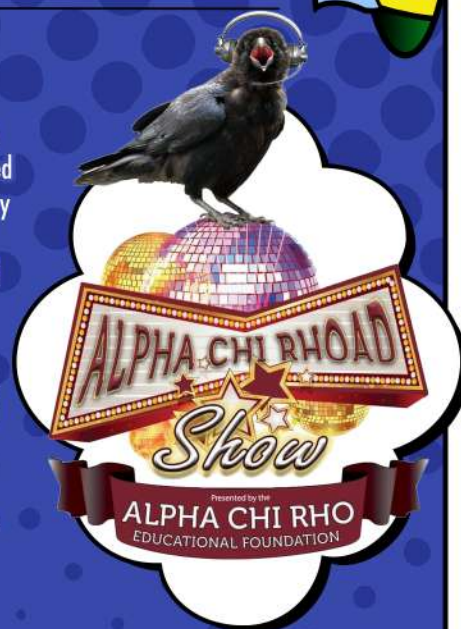

The Superman radio series consisted of five distinct eras starting out in the early part of the 20th century as a syndicated transcribed 15-minute children's serial five times per week. The program always began with the infamous *"Faster than a speeding bullet! More powerful than a locomotive! Able to leap tall buildings at a single bound! Look! Up in the sky ..."*

This heroism theme that was synonymous with the post-world war era reminded me of Alpha Chi Rho around the same time - our predecessors envisioned a separate charitable organization that would champion support for the educational pursuits of our collegiate men. They *listened* to those who lived through the challenging times. They *learned* from their experiences to better anticipate future needs. They *leveraged* the information adjust their mission and stay relevant. In the face of adversity, our Brothers conquered kryptonite. **From the Fraternity emerged the Foundation superheroes.**

Our historical resiliency is related to our progress over the past 5 years.

We LISTENED. We started with social platforms. We posted on Facebook, tweeted on Twitter, and shared stories on Instagram. We heard what you were saying and responded when appropriate. In 2017, the Foundation purchased a new donor management system and discovered that we were missing half of your contact information. We tested several modes of communication, hoping not to overwhelm you, but rather understand what you wanted to know. We began returning our emails and updated your information through our new website. You engaged online and brought others with you. You answered your phones and wanted to know more.

We are LEARNING. As we found more of you, we learned about your interests, created more ways for you to contribute, and provided online donation methods. We highlighted ways to give appreciated stock, employer matching gifts, and set up bequests for the future. We streamlined our publications and used this Annual Report to illustrate your impact on our collegiate men. We learned from your responses to the 2020 Cygnus Applied Research study.
